Probable Cause

On May 11, 2024, the DEFENDANT, Jacob Michael Riggs, violated Florida State Statute (F.S.S.) 893.13(6)(a) - POSSESSION OF CONTROLLED SUBSTANCE, F.S.S 893.147 POSSESSION OF DRUG PARAPHERNALIA AND OR USE, F.S.S 499.03.1 POSSESSION HARMFUL NEW LEGEND DRUG WITHOUT PRESCRIPTION . This incident occurred at McDonald's, 4570 HWY 20 E Niceville, FL, 32578, during a trespass investigation.

Upon arrival, your AFFIANT observed a blue Dodge sedan bearing Florida Registration, BT06YR, as described by the complainant in the rear part of the parking lot, with the rear passenger door ajar.

Your AFFIANT observed DEFENDANT in the driver's seat asleep with a small baggie containing suspected Fentanyl along with burnt aluminum foil and a cut straw on the DEFENDANT'S lap. DEFENDANT awakened as your AFFIANT approached the vehicle and began to reach for the paraphernalia. DEFENDANT was removed from the vehicle and detained.

Based on my training and experience, your AFFIANT recognized the aforementioned items as commonly used equipment associated with narcotics users.

A probable cause search of the vehicle resulted in the following being located:

-Ibuprofen bottle in the center console containing 2 small round pills, beige in color with imprint (U 100).

Your AFFIANT was assisted by D/S Grundin who field tested the substance located in the small plastic baggie from DEFENDANT'S person and it yielded a presumptive positive for Fentanyl.

Your AFFIANT searched for and located the aforementioned pills on Pill Identifier.com and determined the pills to be Quetiapine Fumarate, which is a prescription only medication.

Post Miranda, the DEFENDANT invoked their rights.

Based upon your AFFIANT'S investigation, there is probable cause to believe that the DEFENDANT, Jacob Michael Riggs, aforementioned Florida State Statutes. These offenses are contrary to law, as such case provided, and against the peace and dignity of the State of Florida.
