Probable Cause

On 7/29/2024, at approximately 1630 hours, your AFFIANT conducted a DUI investigation in which Carolyn Green is the WITNESS, and Christine Campbell is the DEFENDANT. This investigation occurred in the area of Forest Rd at the intersection of College Blvd, Niceville, FL.

Your AFFIANT was conducting traffic enforcement of the 4-way intersection of this location. Your

AFFIANT was stationary in his patrol vehicle when the WITNESS approached in the roadway, lowered her window, and began explaining someone was following her. A short time later, the DEFENDANT arrived driving a tan Ford Mustang bearing FL tag CI04EU as the sole occupant of the vehicle. The two began yelling at each other and your AFFIANT separated the two and began interviewing the DEFENDANT. During the interview, your AFFIANT detected the strong odor of an alcoholic beverage emanating from within the vehicle and noticed the DEFENDANT's speech was slurred. The DEFENDANT initially stated she was just going to leave, at which point your AFFIANT commanded her to stay and to provide her driver's license. The DEFENDANT refused to provide her license and the AFFIANT ordered her out of the vehicle. The DEFENDANT was ordered repeatedly to exit the vehicle and refused the command each time. Your AFFIANT attempted to open the door, but the vehicle was locked and the windows rolled up. Your AFFIANT gave warning to the DEFENDANT to exit the vehicle, or her window will be broken. Upon further refusal, Your AFFIANT broke the window of the vehicle and opened the driver's door. The DEFENDANT continued to passively resist and needed to be manually removed from the vehicle with empty-hand control techniques.

While on scene your AFFIANT located a metal cup in the center console with a small amount of liquid at the bottom. This liquid tested positive for the presence of alcohol by an assisting deputy using an Intoximeter Alco-Sensor FST. Green attested in a sworn written statement to erratic driving patterns performed by the DEFENDANT including failing to yield right of way nearly causing a collision and performing a U-turn over a sidewalk in an effort to continue following Green.

An additional witness and brother to the DEFENDANT, Bruce Campbell, stated the DEFENDANT was originally visiting their parent's house before leaving by vehicle. On 8/19/2021, Christine Campbell had the restriction "Business Purpose Only" imposed on her license. This restriction is printed on her license.

During the DUI investigation, your AFFIANT read the DEFENDANT the implied consent warning and requested a chemical test of the breath. The DEFENDANT refused the test and has a documented prior refusal dated 3/9/2021.

Based on this investigation, your AFFIANT has reason to believe the DEFENDANT, Christine Campbell, did violate F.S.S 843.02 Resisting Without Violence, F.S.S 322.16(5) Driving with Restricted License Outside Restriction, F.S.S 316.193(2)a Driving Under the Influence, and F.S.S 316.1939(1) Refusal to Submit to Chemical Test 2nd or Subsequent Offense.
