Jeffrey Womble (Defendant), violated Florida State statute: 893.13.6A; Possession of Fentanyl.

The Defendant was asleep, sitting in the driver's seat of a 1997 Ford Expedition bearing FL tag 2621VP while it was parked and running in the parking area of the aforementioned business.

The Defendant consented to a search of the vehicle. Inside the left pouch of a Gray backpack that was sitting in the passenger seat, I located two small bags of a white powdery substance. The white powder was field tested and yielded a presumptive positive for the presence of fentanyl. The fentanyl was later weighed at 3 grams.

Post Miranda the Defendant admitted the backpack was his but denied any knowledge of the fentanyl.

These offenses occurred in Okaloosa County, Florida, where I am a sworn law enforcement officer.
