#### Probable Cause

From May of 2023 through January 2024, the Defendant, Larry Stidam, violated Florida State Statutes 827.071(5) Possession of Child Pornography (x20) and 934.215 Use of a Two-way Communication Device to Commit a Felony based on the following:

During the month of May 2023, the Okaloosa County Sheriff's Office (OCSO) in coordination with the Walton County Sheriff's Office (WCSO) began working on an Internet undercover operation to identify persons using peer-to-peer (P2P) software on the Internet to traffic in child sexual abuse material.

OCSO Investigator Michael K. Evans knows from training and experience that peer-to-peer networks are frequently used in the trading of child sexual abuse material. For purposes of this report, the term "child pornography" refers to that term as is used in F.S.S. 847.001(3) and children engaged in "sexual conduct" as it is used in F.S.S. 827.071(1) (g).

At the beginning of the investigation, the target Internet Protocol (IP) address, 7\*\*\*, showed the geolocation in Niceville, Walton County. WCSO Investigator Remmington Creamer originally did not have a direct download from the target IP 70.1\*\*\* and observed FBI Special Agent Dan Nowak and Detective John Saltarelli of the Leon County Sheriff's Office had received direct downloads from the target IP address\*\*\* . WCSO Investigator Creamer requested the downloads from both the FBI and Leon County Sheriff's Office.

On June 4, 2023, WCSO Investigator Creamer also obtained a direct download from the target IP address 70\*\*\* . WCSO Investigator Creamer observed the direct download he received and determined the download contained images of child sexual abuse material.

On June 14, 2023, Cox Communications responded to the subpoena stating that the target IP address 70\*\*\* was assigned to Larry M Stidam Jr. of 1708 Valparaiso Blvd, Niceville, FL 32578, between May 2, 2023, and June 15, 2023. WCSO Investigator Creamer observed that the address in the subpoena return came back to Okaloosa County, Florida, and was outside his jurisdiction, so he

passed the case to OCSO Investigator Evans.

On August 4, 2023, Investigator Evans reviewed the downloads from the Walton County Sheriff's Office and Leon County Sheriff's Office and observed that some images and videos violated the Florida State Statute.

During the investigation, Investigator Evans received additional downloads in January 2024 from IP address 7\*\*\* . Investigator Evans reviewed these downloads, which contained images and videos, and observed that they were violations of Florida State Statute.

Through surveillance and law enforcement investigative techniques, your Affiant confirmed that the Defendant lived at 1708 Valparaiso Blvd, Niceville, FL 32578.

On April 4, 2024, a search warrant was executed on 1708 Valparaiso Blvd, Niceville, Florida, and a number of electronic items were seized. During the execution of the search warrant, the Defendant was interviewed. Post Miranda Stidam made the following admissions.

During the interview, the Defendant confirmed that the internet was in his name and that the company was Cox Communications. The Defendant admitted to using the BitTorrent program and to downloading pornography using the BitTorrent. The Defendant admitted seeing child pornography, specifically children posing nude. The Defendant stated he would delete the child pornography after viewing it. The Defendant admitted he would use his HP laptop computer to use BitTorrent. The Defendant admitted to last using BitTorrent in the January/ February time frame of 2024.

A silver HP laptop was found in the living room. The computer has artifacts showing the Defendant as its user and artifacts of the use of BitTorrent during the downloads, which occurred in January 2024. Investigator Evans also discovered images of child sexual abuse material on the HP laptop. In a second laptop, additional child sexual abuse material was discovered. In all, over fifty images and videos were discovered during the forensic review of the computers. The following is an example of the child sexual abuse material discovered:
