06/04/2023 at 1630 hours a white male approximately six foot tall riding a motorcycle pushed and assaulted him in front of the bank over a disagreement. The Victim was pushed several times by the Defendant with force on his chest and back.

A picture of the subject on the motorcycle and the motorcycles registration plate were taken by the Victim. The registration plate was Florida 4QPAL. The subject in the picture was a white male approximately six foot tall wearing a dark blue shirt and grey pants. An address of 305 Pontevedra Lane, Niceville, Florida was discovered for the registered owner of the motorcycle.

I arrived at 305 Pontevedra Lane and observed a white male approximately six foot tall wearing a dark blue shirt and grey pants. I observed a grey motorcycle with the same registration plate as the one in the pictures taken by the victim. I identified the subject as Paul Victor Davies, the Defendant. In a non custodial interview with the Defendant he advised he was in an altercation with the Victim in the parking lot over bad parking. The Defendant approached the Victim and the Victim turned around and walked away stating he was going to call the police. The Defendant grabbed the Victims shoulder/shirt and turned him around, stating the Victim was not going to just walk away from him.

Based on the facts surrounding this investigation probable cause exist to believe the Defendant, Paul Victor Davies, violated Florida State Statute 784.03.1a1 - Battery Touch or Strike.

This Incident occurred in Okaloosa County, Florida where I am a Sworn Law Enforcement Officer
