Multi-Agency Drug Task Force, executed a narcotics search warrant at 301 Goldenrod Court, Niceville, Florida. This is the primary address of Lucas Floyd MCCUBBIN, the suspect of a narcotics investigation. MCCUBBIN was present when the search warrant was executed.

During a post-Miranda interview, MCCUBBIN identified his bedroom. MCCUBBIN advised that Kaitlin McSweeney was selling drugs at the residence, and the two were in a relationship together. MCCUBBIN advised he used drugs and got them from McSweeney. A blue cut straw was discovered during a search of his person in MCCUBBIN's front right pocket. The blue cut straw was swabbed with a sterile swab and field tested, which yielded a presumptive positive result for the presence of Fentanyl.

Based on the aforementioned facts and investigation, Detective Sergeant Usry has probable cause to believe MCCUBBIN violated FSS 893.147 Possession of Drug Equipment. This offense occurred in Niceville, Okaloosa County, where Detective Sergeant Usry is a sworn law enforcement officer.
