Probable Cause

On 1/10/2025, I was assigned to investigate a criminal complaint that occurred at Rocky Bayou Christian School. Victim [REDACTED] is alleging her teacher, Aaron Gleason, was giving her a hug, and slid his hand from her back to her buttocks. This occurred sometime between 12/3/2024 and 12/19/2024, on the Rocky Bayou Christian School remote campus, during school hours, while Gleason was acting as an authority figure.

Initial and forensic interviews (conducted at the Niceville CAC), with [REDACTED] revealed, during Bible Class at Rocky Bayou Christian School [REDACTED] approached her teacher, Gleason, to discuss an assignment; Gleason was sitting down at his desk. At the end of the conversation, Gleason gave [REDACTED] a "side-hug." The hug began with Gleason's hand on [REDACTED] back, and then moved to [REDACTED] buttocks. While Gleason's hand was on [REDACTED] buttocks (outside of her clothing), he began to rub his thumb up and down on her buttocks. Gleason never stood up from his chair during the incident. [REDACTED] said Gleason "kept it there" when describing his hand being on her buttocks. [REDACTED] account was corroborated by two, independent, student witnesses, identified as [REDACTED]

According to [REDACTED] Gleason has made several comments that have made her feel uncomfortable. Gleason asked [REDACTED] if she and her boyfriend were going to cuddle at night. [REDACTED] also claims Gleason told her she looked cute wearing a flower clip in her hair, and then followed this comment up with the question "Or are you just trying to be deceptive?" These comments were corroborated by [REDACTED]. A third witness [REDACTED] advised he did not hear the comment.

Gleason advised he would not give a statement to law enforcement before consulting an attorney.

At the conclusion of the criminal investigation, probable cause has been established to show Aaron Craig Gleason has violated Florida State Statute 800.04.5b-Lewd or lascivious molestation (victim less than 12 yoa, offender 18 yoa or older)

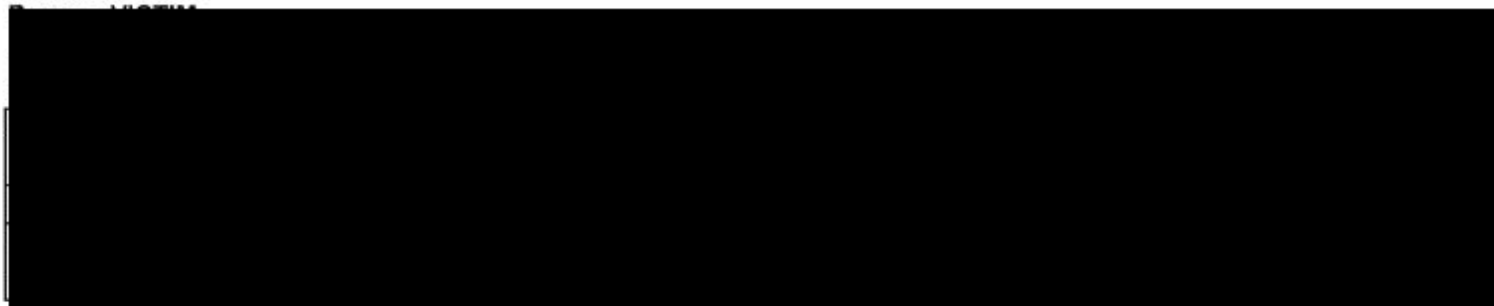
